Product Description: Montmorency tart cherry powder is produced from whole Montmorency tart cherries (*Prunus cerasus*) that have been processed utilizing Good Agriculture and Manufacturing Practices from the orchard to the finished drum-dried powder. The product is allergen and GMO free and meets US EPA Pesticide Residual allowances. It takes approximately 50 kg of whole cherries to make 1 kg of powder.
